

Projects & Partnerships

Environmental Remediation

Replacement of invasive plants with native pollinators continues on the slope from Stanners Street into the park. While controlling the invasives still requires a lot of effort, our native plantings have expanded every year, and we've been able to give away 'volunteer' seedlings at community events. As an added bonus, clearing knotweed has exposed the park's impressive rock formations. We would also like to thank New London Trees for supporting our work by planting native trees both in Riverside Park and in the Cole Street pollinator garden.



Bates (Woods) Friends Forever

Under the fiscal sponsorship of Riverside Park Conservancy, Bates Friends Forever applied for and received 2 grants from CT Department of Energy & Environmental Protection (DEEP) for the purpose of improving the environmental conditions and enhancing public utilization of the natural areas of New London's largest park: (1) Creation of a Forest Management Plan for Bates Woods, and (2) Invasive Plant and Vine Removal in Bates Woods.

East NL Community

Cole Street Pollinator Pathway

A gift from the New London Pollinator Pathway group provided Riverside Park Conservancy with the opportunity to begin planting a native garden on Cole Street, replacing the invasive burning bushes and ailing Japanese cherry trees with a colorful mix of pollinator-friendly trees, shrubs, perennials, and grasses. The project will be completed over the next several years, with existing plantings being removed and replaced a little at a time, so that neighbors will continue to have a vegetative buffer between them and the bridge while the new plants grow to full size.



Riverside Community Garden

At the close of 2025, relocation of the community garden was in process, with remediation of the new site (a former parking lot across the street) nearly complete and plans being made to move the fence, shed and garden beds before spring planting. We are hoping to save several of the fruit trees and shrubs, and plant them outside the fenced area so they'll be accessible to the public. Here is the tentative site plan:
